

## Enable's Biggest Fan Promotion Terms and Conditions

### 1. INTRODUCTION AND ELIGIBILITY

- 1.1 By entering this promotion, all participants will be deemed to have accepted these terms and conditions in full, be bound by the privacy policy (as referred to at paragraph 7) and confirm that they are eligible to enter this promotion and claim any prize they may win. All entry instructions form part of these terms and conditions.
- 1.2 The promotion is open to residents of the UK (excl. Northern Ireland) **aged 18 and over** at the date on which they enter the promotion, excluding employees of the promoter, its group companies, its agents or anyone professionally connected with this promotion and any member of their respective immediate families.
- 1.3 Competition entry opens at **12pm on 29 June 2020** and **closes at 4.00pm on 5 July 2020 (all UK time)**. Entries received after this time and date will be automatically disqualified and not be eligible to win a prize.
- 1.4 The promotion is free to enter and no purchase or payment is necessary to enter the promotion. However, in order to enter the promotion, you must have capacity to submit a picture to social media of your entry and must include the hashtag #GoEnable

### 2. ENTRY TO THE PROMOTION

- 2.1 To enter the promotion, a participant must submit an image or video of their attempt at decorating their living area with as much Enable related decorations as possible. Including but not exclusive to, the Enable fan pack.
- 2.2 Only one entry per household may be permitted.

### 3. WINNER

- 3.1 The winner will be decided by two representatives of the British Champions Series and Great British Racing teams who are independent from the creation of this competition.

### 5. CONDITIONS
